The project

Investigation into the Influence of Promotion and Tenure on Engagement within Open Practices at the School of Education (A pilot study)



Defining "open practices"

The active creation and dissemination of resources using open access practices:

- publishing an open access article
- publishing an open access book
- creating or customizing an open educational resource.



Research Questions

- To what extent is faculty engagement with open practices influenced by P&T policies and procedures?
- How does the influence of P&T policies and procedures on faculty engagement with open practices manifest in relation to other factors, including intrinsic, extrinsic, and contextual factors?



Research based on **Social Exchange Theory**, as outlined in Lwoga & Questier (2014). Looking at:

- Intrinsic Factors
 - Altruism
 - Facilitating Conditions
- Contextual factors
 - Attitude
 - Influence of other actors
 - Culture

- Extrinsic Factors
 - Academic reward / promotion & tenure
 - Usage and Impact
 - Professional recognition
 - Trustworthiness



Research Design

Population: All full time School of Education faculty

Method: Exploratory Mixed Methods

- Initial Quantitative Survey [completed]
- Focus Groups and Interviews
 - Supplement and explain data gathered in survey
 - Currently waiting on IRB amendment approval




Initial Results




Results overview

 - Includes two partial responses


What is your faculty classification?




What is your current rank?



Do you think of yourself primarily as a researcher, primarily as a teacher, or somewhere in between?








Preliminary Takeaways


- Near universal agreement:
 - That open will increase impact/reach
 - In support of open
 - That open benefits society/academia

 General agreement that if required or common in their field, would publish open


BUT

 - Lack of awareness of others' engagement?





Preliminary Takeaways (3)


 Generally did not feel support in promotion and tenure (P&T) practices for engaging with open practices




Open vs P&T










X will adversely affect my chances of tenure and/or promotion

Preliminary Takeaways (4)

 Faculty do not feel supported in their efforts to engage with open (e.g. APC support)

For libraries that offer such support, what can we do to ensure awareness?



What's Next?



Finish data gathering/analysis

- Conduct interviews and focus groups
- Analyze qualitative data and continue analyzing quantitative data



Refine and Expand

- Refine survey based on results and qualitative data collection
 - Potentially conduct further cognitive testing to refine survey instrument
- Expand survey to other SoE* in Virginia
 - Apply for additional grant funding
 - Let us know if you're interested in partnering

Author recommendations for VCU (and potentially other surveyed schools/white paper) on what adjustments to P&T (or other policies) may best pave the path for higher faculty engagement with open practices
