

VCU Sponsors Forum on Northern Ireland

Solutions to Northern Ireland's complex social, religious, and economic problems can not be found in sectarian violence, according to participants in "Face to Face with Northern Ireland," a peace forum held March 11 at VCU. The forum brought together, for the first time in this country, clergy and political leaders to discuss peaceful solutions to the continuing civil war in Northern Ireland.

The speakers—Protestant and Catholic, British and Irish—agreed that foreign investment, increased employment opportunities, and an end to injustice and discrimination are essential to establishing peace in Northern Ireland

Members of the panel included the Most Reverend Edward Daly, Roman Catholic bishop of Northern Ireland; the Right Reverend James Mehaffy, Anglican bishop of Derry and Raphoe, Northern Ireland; Denis Haughey, international secretary of the Northern Ireland Social Democratic and Labour Party; Padraic N. Mackerman, Irish ambassador to the United States; and Brian J. P. Fall, minister at the British

Embassy in Washington. Petitioners included the Most Reverend Walter F. Sullivan, bishop of Rich-mond; Dr. Kathleen F. Slevin, associate provost, The College of William and Mary; and the Reverend Benjamin P. Campbell, chaplain to the bishop of Virginia Episcopal Diocese of Rich mond. Dr. Lynn Nelson, professor, Department of Sociology and Anthro-

pology, moderated the discussion. Speaking to the problem of continued violence in the province, Daly discussed scenes that appear daily in the national press. "I see young people full of anger. Injustice sows the seeds of violence he said. "I've given last rites to 40 or 50 people on the streets since I've been bishop. I've picked up parts of bodies that were blown apart by bombs. War is so, so cruel." Mehaffey, who is a close friend of

Daly, agreed that there is injustice in the province and insisted that violence is not the way to remedy the problem.

"Violence breeds violence and has no part in any solution," he said. "There is no easy solution to the problem. We must work together.

The forum was sponsored by the Children's Program of Richmond, Maymont Foundation, the Richmond Peace Education Center, and VCU.

Marketing Expert is Scholar-in-Residence

moving to a one-world economic system. He writes that "the United States is becoming more economically interdependent with the rest of the world

VCU Receives \$250,000 From A. Kemp Rowe

The Campaign for VCU has received a gift of \$250,000 from local real estate developer A. Kemp Rowe, a graduate of VCU's School of Business. Rowe's contribution is the largest lifetime gift from an alumnus to the Campaign for VCU and the second largest gift ever from an alumnus.

Most of the unrestricted gift-\$240,000-will be used to establish the Rowe Athletic Excellence Fund to enhance the men's basketball program. The real estate program in the School of Business will receive \$10,000. Funds to the Athletic Department will

enable the University to expand its scholarship program, provide additional unrestricted income to the athletic director, and establish the "Rowe Classic" to attract prominent men's basketball teams to Richmond on an annual basis

Rowe holds two degrees from VCU. He received a bachelor's degree in business in 1967 and a master's degree in finance in 1971. He is president of Richmond-based Rowe Development Company which has branches in Bethesda, Nashville, Newport News, and Virainia Beach.

Plan Now for Year-End Procurements

Although there are still three months remaining in the current fiscal year, it is not too early to begin anticipating yearend procurement requirements, accord-ing to James M. MacMillan, Jr., director of procurement and stores. "By planning for the year-end in

advance, we will be able to reduce the volume of requests we normally receive as June 30 approaches," says MacMil-Ian. "That way we can be more responsive to everyone's needs.

In order to allow sufficient time for delivery and payment of invoices prior to June 30, requisitions for all major procurements should be submitted by April 1. Lapse of funds at the end of a fiscal year is not considered an emergency and can not be used as justification for a sole source procurement, according to MacMillan.

Measures Taken to Expedite Building Repair Needs

The provost's office and the Facilities Management Physical Plant Department have been working cooperatively to address the repair needs of facilities on the Academic Campus. To facilitate communications and to expedite the completion of work orders, two or more individuals in each facility on the Academic Campus have been identified—the building manager and the building repair representative.

The building manager is the individual who should be contacted for major matters that affect general occupancy of a building, e.g. a fire which affects rescheduling classes.

The building repair representative is the individual who reports a need for repairs for facility-related conditions to the Facilities Management Physical Plant dispatcher. By funneling work order requests through the building repair representative, the dispatcher will not be flooded with several requests on the same condition. In addition, the dispatcher will report the progress and completion of work orders to the building repair representative.

Work orders are placed into three categories (priorities)

Priority I: Emergency calls are answered within one hour (or sooner). They include situations dealing with life/safety matters, building damage, or interruption of classroom schedules.

Priority II: Rush work requests are answered within eight hours (providing materials are available). These calls do not deal with "Priority I" matters but include such conditions as lack of air conditioning/heat in a single area, a burned-out light bulb, or a stopped-up toilet in an area where other toilets are available.

Priority III. Routine maintenance that must be scheduled such as plastering and painting.

The names of the building managers and the building repair representatives are listed here for your convenience.



"I have tried to get involved in activities that apply to my classes."

Recreation has always depended on volunteers in the delivery of services, according to Dr. Michael S. Wise, professor, Department of Recreation, Parks, and Tourism. So it's not unusual that Wise has spent a great deal of his professional career volunteering.

It is also not that unusual that Wise will soon take on one of the most challenging volunteer positions anyone could assume. He will become president of the Jewish Community Center in May.

"All of my volunteer experience has

been targeted to enhance the practicum side of my training," he says. "I have tried to get involved in activities that apply to my classes. That is part of the aim of a professional school."

Wise sees volunteerism as a two-way street. During his 16 years at VCU, he has continually sought out ways to increase his expertise, while at the same giving something back to the community. In addition to service for the Jewish Community Center, he has served on boards for the United Way, Richmond Community High School, and the Virginia Recreation and Parks Society.

"Many community leaders have helped me get a good perspective on the Richmond community," says Wise. "I have had some excellent mentors, and I hope to be a mentor to other people."

Wise's two-year appointment will include working with the 36-member board and the officers. He feels it's a very talented and committed board, and that many of them spend upwards of 20 hours a month on volunteer activities for the Jewish Community Center.

"My involvement will allow me to look at my concepts of volunteerism and recreational delivery systems," he says. "It will give me insight into how to reassess and redesign the delivery of recreation systems."

Wise adds that he feels the Richmond community has opened its arms to VCU, especially the faculty and staff.

"We're doing our fair share for the city," he says. "That's one of the reasons I chose to work at VCU. I'm involved, and I want to give back to the community. There are mutual benefits."




