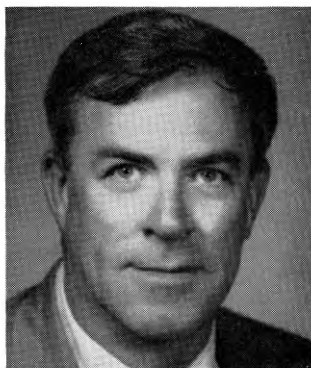
James L. Mathis (*Psycho-Social Aspects of Drug Abuse by Modern Youth*) is professor and chairman of the department of psychiatry at the Medical College of Virginia. After attending undergraduate school at The Citadel in South Carolina and the University of Missouri, he received his M.D. from St. Louis University School of Medicine. Dr. Mathis began his medical career in general practice, but in 1960 entered a psychiatric residency at the University of Oklahoma Medical Center where he went on to hold the positions of instructor and assistant professor of psychiatry. Before coming to MCV, Dr. Mathis was associate professor of psychiatry at Rutgers.



Hugh McMahan (*Severe School Phobia*) is a senior medical student at the Medical College of Virginia, and recipient of the 1970 MCV Faculty Award in Child Psychiatry. Mr. McMahan received an A.B. from Bowdoin College in Brunswick, Maine.

Before coming to MCV, Dr. Powers was director of the Bristol (Virginia & Tennessee) Mental Health Clinic, and director of child psychiatry at Vanderbilt.



Virginia A. Saunders (*Special Characteristics of Adopted Children and Adoptive Parents as Seen in a Psychiatric Practice*), a psychiatric social worker with Dr. Lillian C. Lindemann, has had an active career in social work for the past 20 years in Virginia. She has worked with the Child Care Bureau of the Department of Welfare and Institutions, the Virginia Methodist Children's Home, the Child Welfare Division of the City of Richmond, the Family and Children's Service of Richmond, and the Virginia Treatment Center for Children where she was supervisor of psychiatric social work.
