August 12, 2009 Meeting of the Academic and Health Affairs Policy Committee

A meeting of the Academic and Health Affairs Policy Committee of the Board of Visitors of Virginia Commonwealth University was held on Wednesday, August 12, 2009, at 10:30 a.m. in the Richmond Salons 3 and 4 located in the University Student Commons at 907 Floyd Avenue.

Present were Messrs. Jones (Chair), McCandlish, Morse, Robertson and Rosenthal; and Dr. Shapiro. Dr. Romano was absent. Also present were Drs. Rao, Corey, Gottfredson, Huff, Macrina, Moriarty, Parmley, Retchin, Rodriguez and Vetrovec; Messrs. Bunce and Ream; and Mesdames Abernethy, Collier, Covington, Harris, Janis and Stillman.

Mr. Jones called the meeting to order and on motion made and seconded, the Minutes of a Meeting held August 14, 2009, were approved.

A report on Degrees Awarded and the Virginia Commonwealth University Health System Financial Statement Summary for Fiscal Year 2009 – Eleven Months Ending May 31, 2009, were presented for information.

On motion made and seconded, the Academic and Health Affairs Policy Committee convened into closed session to discuss certain personnel matters involving the performance of identifiable employees or faculty of VCU, and to discuss the evaluation of the performance of departments or schools of VCU where such evaluation will necessarily involve discussion of the performance of specific individuals, and the performance of University departments and schools as related to the Medical College of Virginia Hospitals and the Virginia Commonwealth University Health System Authority; and consultation with legal counsel as authorized by Section 2.2-3711 A(1) and A(7) of the Virginia Freedom of Information Act.
