May 20, 2010 Meeting of the Audit and Compliance Committee Minutes

A meeting of the Audit and Compliance Committee of the Board of Visitors of Virginia Commonwealth University was held on Thursday, May 20, 2010, at 9 a.m. in the Richmond Salons located in the University Student Commons at 907 Floyd Avenue.
